

Regarding the alleged irregularities in an entrance exam where a senior official of the Ministry of Education, Culture, Sports and Science and Technology (MEXT), who is a father of an examinee for Tokyo Medical University (private university), and a broker (an intermediary between a candidate for a university and a university) were arrested on July 4, 2018 and the President of Tokyo Medical University and the chairperson of its board of regents resigned from their respective posts on July 6 and were prosecuted on July 24 in Japan, I respond to this serious social issue and attach my statement to all mass media around the world as follows.

As you know, I, Yukihisa Shida, have specialized in research on this issue since 1999 as a doctor of national Mie University. Probably, I am the only one researcher or educator who have disclosed and posted the situation regarding the irregularities (backdoor) in entrance examination on an academic website, "chairperson.jp" since 2016 from the doctor's perspective in the world. While engaging in daily clinical practice as a physician in the Tokyo Metropolitan area, I concurrently conduct studies and provide education on "Sports and Medical Education" outside the Japan Society for Medical Education on a continuous basis. Please refer to "Paper on August 1, 2016 (World Federation for Medical Education) regarding a discussion between Chairman David Gordon of the World Federation for Medical Education and me at a lecture held at the Medical Education Center, Kyoto University (established in 2004) on August 1, 2016 to see how I position my research. And I introduced myself to French Ambassador to Japan on September 18, 2018, saying that "Probably, I am the only one researcher in the world who focuses on irregularities (backdoor) in entrance examinations for universities like Tokyo Medical University. And it's my honor to introduce to Mr. Ambassador that I will make a statement to the mass media around the world about irregularities (backdoor) in entrance examinations for universities in Japan on our academic homepage 'chairperson.jp' this

month." Also, you are free to use or quote the academic website, "chairperson.jp" if you make the source clear, as is the case with National Cancer Center Japan's homepage.

Though it is an unnecessary addition, first and foremost, as is the case with Teikyo University Group's Presidents Yoshihito Okinaga (Mediocrity «Bonsai») and Hiroko Okinaga (Brilliant «Shuusai»), people, including, Dr. Masahiro Kami (Brilliant «Shuusai»), former Professor of Teikyo University and the University of Tokyo, who

had a hands-on experience in backdoor admissions as a teacher at a private university and held responsible, have no alternative but to talk about their own backdoor admissions (use of an entrance exam broker and tuition of 60 million yen). It is problematic that "a scholar who wants to appear in the media" is given priority over "a scholar the media wants to pick up," or "the University of Tokyo's clique which has 10th Dan (rank) in shogi (Japanese chess) dropped the 'Lance piece, former professor Masahiro Kami ' to 1-A by the first move on the shogi board." They should not forget that they put their issues on the shelf. Therefore, it is important to ask a brilliant doctor, a doctor of medical science who graduated from a public university and has never worked for a private university for a comment. However, I would like to take this opportunity to ask you to understand that if academic comments on irregularities (backdoor) in entrance examinations by a doctor of medical science who graduated from the University of Tokyo and Kyoto University are covered by the mass media, including a TV broadcast or newspaper publication, it will eventually encourage academic harassments of scholars who graduated from national universities other than the University of Tokyo or Kyoto University, making feel strange

by dropping their heads abruptly and giving a sigh. For further information, please refer to "Paper on July 25, 2012 (The University of Tokyo, The University of Manchester)" and "Paper on May 30, 2015 (Japan Society for Medical Education)."

For your information, I worked with a neurosurgical doctor who graduated from Showa University for eight months before. His clinic has many mistakes in kanji (Chinese characters) which are often confused homonyms, including "jushin" (receiving an e-mail or seeing a doctor) or "yobou-sesshu" (intake or vaccination) on the clinical records. And Japanese in the mass media misunderstand and write that "Dr. (Sensei)" is "Mr. (San)," "Bachelors (the third place)" of national universities are "Doctors (the first place)," "Mediocrities" of private universities are "Brilliant" people who pass entrance examinations for national universities, or doctors with low-level humanity who have an inappropriate relationship with nurses at work have high-level humanity. Japanese mass media should review their "ahokusai (foolish) work like Waseda University's style." Regarding the Tokyo Medical University scandal in 2018, mass media around the world may get the wrong idea that this scandal forms "Irregularities (Unfair) in entrance examinations based on discrimination against women." However, candidates for a university who took entrance examinations other than sons and daughters of graduates of the university were also relatively discriminated. As I have told in my papers since 1999, the essence and core of this scandal is not "Irregularities (Unfair) in entrance examinations based on discrimination against women," but "Irregularities (Backdoor) in entrance examinations using a broker" from the academic viewpoint of medical education.

Academic Statement about Tokyo Medical University's Irregularities (Backdoor) in Entrance Examination in the 21st Century (September 1, 2018)

Our entrance exam is conducted not through an individual name but through an examinee's number alone and it is not done behind closed doors. More than one member of staff and teacher check exam papers several times and they go through an entrance exam screening meeting and only those examinees who are approved by a meeting composed of responsible eminent professors will pass the exam and be admitted. Even if an examinee who failed the exam files a complaint with his/her lawyer, calling for an explanation or the Ministry of Education, Culture, Sports and Science and Technology (MEXT) makes on-site inspections after the results of an exam are announced, we will be able to prove that there is no problem with the entrance exam process. Thus, there are no backdoor admissions. Pointing out the irregularities (backdoor) in entrance examination is a misunderstanding of the matter. In the first place 21st century Japan, backdoor admissions are a story only in a movie, TV drama or a developing nation and it is not possible. There are almost no discussions, papers or experts on corrupt admissions, much less neither the Japan Society for Medical Education (JSME) nor the mass media point them out. In the 20th century, in an entrance exam to medical departments of private medical universities in Japan, such as Aichi Medical University and Kitazato University, someone was said to have been admitted if he/she scored nil in English and 15 in total out of 100 points. In the current 21st century, however, despite a wide variety of routes, such as move up success, admission on recommendation, escalator admission (private school that allows students to advance from one stage of education to the next), a college transfer exam, Admission Office (AO) entrance exams or study abroad entrance exam, unless you are one with "ordinary" mediocrity (with deviation values from 40 to 49) to pass other competitive universities such as Soukei (Waseda, Keio), Kankandouritsu (Kansai, Kwansei Gakuin, Doshisha, and Ritsumeikan), you would not be able to pass an entrance exam. [Today, if you are an amazingly rich son or daughter who is well brought up and you can use an entrance exam broker and offer a lot of money for school bonds or donations worth more than 60 million yen, unless his/her deviation value is 40 or higher, he/she cannot be admitted to the faculty of medicine (department of medicine) of private universities (based on deviation values of 50 or higher for national universities, such as Mie University and Fukushima University).] The deviation values of successful applicants (not move up successors) of the medical department of universities that cram schools survey and unveil annually and the passing rate of a national exam (which will be easier to pass in the 21st century and additional school expenses and taxes will be used on students who repeat the same year) that is conducted by the Ministry of Health, Labor and Welfare is as high as those of national and public universities and universities clearly indicate on their websites tuitions that have recently been reduced to tens of millions of yen over six years. We have the system of university entrance exams to ban to sell school bonds or receive donations to a university before announcements of test results or admission.

Needless to say, as regards scores of entrance exams, there are crystal-clear strict acceptance criteria for academic exams, exams for admission on recommendation, escalator or study abroad entrance exams, set by the respective private universities and there are some brilliant entrance exam takers and graduates who could pass entrance exams of the medical department of national universities (who are said to be smarter or have a higher IQ than Prime Minister Shinzo Abe who has a bachelor's degree in law from Seikei University and Diet Member Shinjiro Koizumi who is good at English and has a master's degree in political science from Columbia University). It is not unusual for an even medical student to see his/her academic performance rank high in the faculty of medicine at a private university and actually, there are quite a few brilliant people among marriage partners, doctors who work for hospitals after graduating from medical school, nurses, receptionists, bosses, colleagues or subordinates (who are said to be smarter than anchor Toshiaki Megumi with a high school education or Ayaka Ogawa, a TV anchor who graduated from School of International Politics, Economics and Communication of Aoyama Gakuin University who often appear on TV) who got a passing score in entrance exams of national universities (whose deviation values are 50 or higher).

There are some who become a certified doctor by the Japan Medical Association or Japan Societies, are qualified as a specialist physician or have studied in the U.S. after passing a national exam for medical practitioners. In the Tokyo Metropolitan area, the number of the faculty of medicine, university hospitals or patients is larger than that of national universities and private universities have produced higher clinical, research and educational results. Private Fujita Health University, which is called the world's No. 1 university for preppy boys and has the largest university hospital in Japan, and private Kinki University that is one of Soukeikin (Waseda, Keio, Kindai) and has an image song of Kinki University: 'Nande Kindai? — Why do we become a student of (below average and unintelligent) Kinki University (as the same as famous show business people like Ryouko Suehiro or Sho Sakurai)?' are one of Japan's top university brands and their university hospitals are booked up by patients. In a hospital in town, it is not unusual when the No. 1 examination room is taken charge of by a Doctor of Medical Science who graduated from a private university and Nos. 2 and 3 examination rooms by those who graduated from national universities. In an alumni reunion by a private university, the number of graduates is large who are university professors, presidents of medical institutions or directors of hospitals who perform a leadership or managerial role and keep a close watch on healthcare, which bears comparison with that of public universities on the one hand. On the other hand, cases of overlooking the signs of a disease at national Nagoya University Hospital were reported and as the former medical director at Chiba Cancer Center who is a brilliant doctor who graduated from national Chiba University, there are doctors of medical science whose ability is on par with that of a nurse and who lack a sense of tension and whose reputation has to be revisited. As a doctor of private Teikyo University Hospital filed a lawsuit, we have past performance and can from time to time look down upon brilliant doctors who work for national university hospitals or graduated from national universities. For your information, it was pointed out at the International Research Center for Medical Education, the University of Tokyo (established in 2000) that former vice president of private Tokyo Medical University left his medical charts blank as poor as "Zero Marks Medicine" (like a case daily happened in a developing country) in January, 2013. A similar case was also reported that former professors and others of national

Mie University left their medical charts blank in the same way in their clinical practice, research and education at the Japan Society of Hepatology and others but it did not become controversial from the medical risk standpoint according to precedent.













"Unfortunately, they are said to be mediocrities (*Bonsai*) though they study for entrance exams at their own rich home in Japan. For example, it is meaningless to enter Columbia University or Waseda University and they are not regarded as "brilliant." However, if they are not only talented (*Yuushuu*') but also 'ordinary' mediocrities (with deviation values from 40 to 49), they will probably be able to become medical doctors who used an entrance examination broker and paid more than 60 million yen to third-class private universities. They will be no more than backdoor doctors in the bottom of the medical field through life, although actual medical doctors in Japan like backdoor doctors of Teikyo University, Tokyo Medical University in the 21st century."



In the 21st century, private universities that came to an issue due to their backdoor entrance examinations, such as Teikyo University and Tokyo Medical University, have strongly repeated a similar statement like this openly or implicitly. As regards entrance exam brokers (who serve as a go-between for those who sit for an exam and universities, including members of the Diet and alumni of universities) and tuitions, including bonds or donations, there has been no disclosure from private universities over the past few decades while the mass media, including the NHK public broadcast station, have almost not reported, which I believe is the present situation of Japan. As you are aware, I have conducted research on this issue since 1999 as M.D., Ph.D. of Mie University and probably I have been the only one researcher or educator specialized in irregularities (backdoor) in entrance examination for university from the doctor's perspective in the world and posted my research results on the academic homepage "chairperson.jp" since January 26, 2016. In order to shed light on corrupt admissions in Japan from a medical education perspective, as I have repeatedly posted academic papers on the website, "chairperson.jp," I believe that it is essential to conduct inspections into entrance exam brokers and more than sixty million yen medical tuitions, including school bonds and donations, and disclose the findings.

Moreover, overseas, in Russia and China, the home of backdoor admissions, and also at Harvard University, Oxford University or Paris University, it is difficult to say that currently, the transparency of entrance examinations is fully secured. Under such circumstances, at least Japanese public broadcast station NHK should cover a story of an entrance exam broker used by candidates for Fujita Health University, a medical university which call its university hospitals "educational hospitals" and charges the highest tuition for medical education in Japan, and high tuition (medical educational expenses) that developing nations in Asia look up, and broadcast it in its Today's Close-up plus (NHK's social affairs show). Japan from which overseas countries seek economic assistance, where one out of seven children is poor, cannot afford to inject massive amounts of taxpayers' money in domestic well-to-do private universities where justice, fairness and transparency among exam takers is not ensured. Conspicuous foreign or high-end cars are lined up in parking spaces for doctors. When Mr. Ben Johnson, an athlete who represented Canada, was disqualified in the final analysis at the Seoul Olympic Games in 1988, the nation lamented by saying, "What happened to you, Ben?" because of not his 9.83 record in the 100-meter dash per se but a problem that was identified in his way of doing it or historical background that led to the outcome. I would appreciate it if you could understand the meaning of the academic website, which is at the same level as those of professors of Osaka University who work, study and research with a sense of tension, brilliant people and doctors, not the level of private universities, mediocre people, graduates of private universities such as Nihon University and Waseda University. It seemed that the academic website, "chairperson.jp" was too complicated for General Manager (Bachelor degree) of Fairmont Hotels, Canada's leading hotel chain in Vancouver where I visited on my business trip today, August 1,

2018年7月4日、受験生の父親である文部科学省の局長及び私立東京医科大学の入試 Broker(受験生と大学の仲介者)が逮捕され、7月6日私立東京医科大学の理事長並びに学長が辞任後、7月24日に起訴されました日本の私立大学医学部の不正入試に関しまして、私、志田幸久(国立三重大学出身、医師)からの学術的な Statement を記載致します。私、東京首都圏におきます日常の内科臨床に加え、研究と教育「Sports と医学の教育」を日本医学教育学会外で当面継続していますところです。

知ってみえます様に、私 志田幸久は、国立三重医学博士として 1999 年から Research を重ねておりまして、医師の立場から不正(裏口)入試を専門としました恐らく世界で唯一の研究、教育を 2016 年より学術 Homepage「chairperson.jp」にて発表、公開させていただいてます。Research の位置づけとしましては、2016 年 8 月 1 日、京都大学 医学教育推進センター(2004 年設立、現 京都大学 医学教育・国際化推進センター)講演会におきましての、私と世界医学教育連盟 David Gordon 会長との Discussion「Paper on August 1, 2016 (World Federation for Medical Education)」をご参照下さい。 2018 年 9 月 18 日も、「Probably, I am the only one researcher in the world who focuses on irregularities (backdoor) in entrance examinations for universities like Tokyo Medical University. And it's my honor to introduce to Mr. Ambassador that I will make a statement to the mass media around the world about irregularities (backdoor) in entrance examinations for universities in Japan on our academic homepage 'chairperson.jp' this month.」と France 駐日大使に自己紹介させていただきました。学術 Homepage「chairperson.jp」のご利用、引用につきましては、国立がん研究センターの学術 Homepage の案内と同様、出典を明記していただければ Free です。

ちなみに、私立大学の教官として、自らも不正入試の経験、責任がある上昌広 元帝京大学教授 兼 元東京大学教授などは、冲永佳史(凡才)、冲永寛子(秀才)帝京大学 Group 両学長と同様、まず自らの裏口入試、入試 Broker と 6 千万円の学費の考え方について話さざるを得ません。 「マスコミに出したい人より、出たい人」「先手、東京大学学閥 十段、1 一香(上昌広 元教授)打つ」では如何なものでしょう。ご自分、ご自分達の Team のこ

とは、棚の上に上げて忘れましたでは困ります。従いまして、不正(裏口)入試につきましては、日本では国公立大学出身かつ私立大学常勤勤務歴のない秀才の医師、医学博士に Comment を依頼されることが肝要ですが、東京大学及び京都大学医学博士による私立大学不正(裏口)入試に関する学術 Comment を新聞、TV など Mass Media 各社が取り上げられることは、結果的に東大、京大学閥以外の国立大学出身の学者にご自分達のガクッと落ちる頭を見せつける、溜息を聞かせるなど違和感を感じ、問題のある Academic Harassment を助長することになっていますことも、この機会にお分かりいただければと思っています。詳細につきましては、学術 Homepage「chairperson.jp」内、Paper on July 25, 2012 (The University of Tokyo, The University of Manchester)、Paper on May 30, 2015 (Japan Society for Medical Education)等をご参照下さい。

なお、以前昭和大学出身の脳神経外科医と8ヵ月程一緒に仕事をさせていただいた時に多かったのが「受信(受診)」と「予防摂取(予防接種)」の誤字でしたが、日本の Mass Media の皆様に多く拝見します間違いが、「Dr. (先生)」を「Mr. (さん)」、「(3番の)学士」の国立大学出身者を「(1番の)博士」、「凡才」の私立出身者を「(国立大学に合格する)秀才」、また勤務先の看護婦と不適切な関係を持つ「(人間性が)下」の医師を「(人間性が)上」との言い方、書き方です。「(関西弁で、早稲田大学風)あほくさい仕事」は、見直ししていただいた方がよろしいかと思います。また今年2018年の東京医大不正入試発覚につきましては、「女性差別の不正入試」との認識、勘違いをしてみえる様ですが、東京医大同窓生の子弟以外の受験生も差別されており、1999年から私論文で述べてます通り、医学教育の学術上は「女性に対する不正(差別)入試」ではなく、「入試 Broker を使った不正(裏口)入試」が問題の本質かつ核心です。

私立東京医科大学の不正(裏口)入試についての学術 Statement(2018年9月1日)

入試選考は、個人名ではなく、受験番号のみの扱いで密室では行われていない。複数の大学職員、教官により複数回 Check され、入試選考会議での確認を経て、全ての教官を代表する錚々たる教授陣で責任をもって承認された受験生のみが合格、入学許可となる。また、入試結果発表後、仮に不合格になった受験生が弁護士を立てて説明を求めても、文部科学省が大学に立ち入り調査しても、大学における入試選考過程に間違いのないことが証明出来る。従って裏口入試ではなく、全くの誤解。21世紀の日本では、裏口入学は映画、TV Drama、発展途上国の中でのお話で、そもそも日本医学教育学会、Mass Media において、裏口入試の指摘はおろか、議論、論文、そして裏口入試の専門家もまず見当らない。20世紀、学科試験で100点満点にして、英語が0点、総合点で15点まで入ったと言われる私立愛知医科大学、私立北里大学などの私立大学医学部医学科も、

21世紀の今は、学科試験繰り上げ入学、推薦入試、エスカレーター入試、編入学入試、AO入試、留学入試等であっても、早慶、関関同立の難関私立大学と同じく、普通の凡才(偏差値 40 台程)でないと入学の扉は開かない。[今は、たとえ入試 Broker を使って 6,000 万円以上の高額な学債、寄付金を申し出るすごいお坊ちゃま、お嬢さまでも、私立大学医学部医学科は(三重大学、福島大学などの国立大学の学科試験偏差値を 50程以上として)普段偏差値 40 はないと厳しい。入れない。] 大学予備校が毎年調査、発表している医学部医学科(繰り上げ入学者ではない)合格者の学科試験の偏差値、並びに労働厚生省が施行する(21世紀には易しくなり、また留年生にはさらなる学費、税金も掛けられる)医師国家試験の合格率は国公立大学並みに高い。大学 Homepage では、近年値下げした 6 年間で数千万円の学費を明示し、大学への学債、寄付金に関してはあくまで任意で、大学入試の System 上、合格発表、入学前には収めてもらうことが出来ない。

もちろん受験生の入学試験点数に関しては、1点の操作、曇りもなく、学科試験、推薦試験、エスカレーター入試、留学入試など私立大学で定めた合格基準があり、入学生、卒業生の中には他に国立大学の学部入学学科試験の合格点を取れる余裕のある(成蹊大学法学学士の安倍晋三総理、英語がお得意で Columbia 大学政治学修士の小泉進次郎議員のお二人より頭がいい、IQ が高いと言われる)秀才もいる。普通の凡才医学生でも、私立大学医学部内での成績が上になることが珍しくなく、結婚の Partner、卒業後勤務病院の医師、看護婦、受付などの上司、同僚、部下の中には、国立大学の学部入学学科試験の合格点を実際に取っている(TV によく出てみえる高校卒業の恵俊彰キャスター、青山学院大学国際政治経済学士の小川彩佳キャスターのお二人より頭がいい、偏差値にして平均の50以上程と言われる)秀才も少なくない。

医師国家試験合格後は学会または日本医師会の認定医、専門医を取得する他、米国留学経験のある医師もおり、東京首都圏では、国公立大学より私立大学の方が医学部、大学附属病院、患者さんの数が多く、より臨床、研究、教育の実績が出ている。「世界一のお坊ちゃま大学」との呼び声高い日本最大の大学病院を有する私立藤田保健衛生大学(2018 年 10 月より藤田医科大学に改名)、Image Song「なんで近大(小学校では神童、中学では天才と言われていたのに、なぜ私達は平均以下、近大の、《有名 Talent の広末さん、櫻井翔さんと変わらない》凡才学生になったのか)」を持つ、早慶近の私立近畿大学も、その日本の私立大学 Top Brand で大学病院は患者さんの受診予約でいっぱい。市中病院でも、外来の第 1 診察室が私立大学医学博士、第 2、第 3 診察室が国立大学医学博士であっても不自然ではなく、私立大学同窓会においても、大学教授、医療機関の理事長、院長など指導的、経営的立場になり医療をまとめ、見守っている医師の卒業生も多く、国公立大学の同窓会に比べても遜色がない。その一方、例えば国立名古屋大学病院ではレントゲンの見落とし症例が見受けられ、千葉県がんセンター(元)医長の様に、「尊敬できる千葉大学の秀才医師」との扱いに、見直しが必要な程緊張感に欠ける看護師程度の国立大学医学博士もおり、時に私達は、(元)私立帝京大学病院医師が裁判に訴えたがごとく、国立大学病院並びに国立大学出身の秀才医師をも見下せる実績がある。なお国立東京大学 医学教育国際協力研究センター

(2000年設立、現 国立東京大学 医学教育国際研究センター)で、私立東京医科大学(元)副学長の(発展途上国の様な)医師カルテ白紙、「0点の臨床」が(2013年1月に)指摘されたが、過去国立三重大学の(元)教授等も日本肝臓病学会等で医師カルテ白紙の臨床、研究、教育が同様に報告されており、前例に従い医療 Risk の観点からも深い、厳しい議論にはなっていない。

21 世紀、裏口入試で問題になった帝京大学、東京医科大学を含む日本の私立大学では以上の様な主張が表立って、また暗に、繰り返し強くなされ、入試 Broker(受験生と大学との仲介者:国会議員、大学同窓会関係者など)並びに学債、寄付金を含めた医学教育費については、今世紀、私立大学からは情報開示がなく、公共放送 NHK を始めとする Mass Media もほぼ報道せず、との事実が日本の現状と思われます。医学教育の学術上、日本の裏口入試の全容解明のためには、Homepage「chairperson.jp」掲載の学術 Paper に繰り返し記載して来ました様に、入試 Broker(受験生と大学との仲介者)並びに学債、寄付金を含めた6千万円以上の医学教育費の調査、公開が、私 不可欠と考えております。

海外におきましても、不正(裏口)入試の本場、Russia、中国の大学はもちろん、Harvard 大学、Oxford 大学、Paris 大学でも大学入試の透明性が十分確保されているとは言い難いのが現状ですが、少なくとも日本の公共放送 NHK は、大学病院を「教育病院」と銘打たれ、日本最大の医学教育費用を掛けてみえる私立藤田保健衛生大学の受験生が使う入試 Broker と、Asia の発展途上国から見上げられる高い学費(医学教育費)をまとめ、クローズアップ現代プラスで公表すべきでしょう。海外から経済援助を求められ、7人に1人の子供が貧困の日本社会において、受験の公正性、公平性、透明性が保たれていない国内の裕福な私立大学に、多額の税金を投入する余裕はありません。医師駐車場にも贅沢な外車、高級車が並んでいます。 Canada 代表の Mr. Ben Johnson が 1988 年の Seoul Olympic で最後失格になり、Canada 国民の皆さんが「どうした Ben」と嘆かれましたのは、Olympic Game で世界中の目が注がれる中厳格に測られた 100m 9.83 秒の記録ではなく、その結果に至った Athlete 自身のやり方、経緯に問題を認めたからです。国立大阪大学教授陣の「緊張感のある仕事(勉強、研究)」「秀才」「博士」三拍子揃った Level での難しい学術Homepage ですが、ご理解いただければ幸いです。私立日本大学並びに私立早稲田大学出身者等の「緊張感のない仕事(勉強、研究)」「凡才」「学士」Level ではなく、本日 2018 年 8 月 1 日、出張にて訪れています Vancouver 市内の Canada を代表する Hotel group、Fairmont Hotels の General Manager におかれましても、Sports 界の底、Mr. Ben Johnson 並びに医学界の底、新谷正義国会議員(?)など、学術 Homepage「Chairperson.jp」の内容は難解でみえた様です。今後共、どうぞよろしくお願い申し上げます。
