



The Supreme Court of California and Chief Justice Tani Cantil-Sakauye

Interpretation of the academic paper “Paper on June 21, 2019 (The Nagoya High Court, Japan)” and “Paper on July 1, 2019 (The Tokyo High Court, Japan)” on the homepage “chairperson.jp” for The Supreme Court of California, U.S.A.

Dr. Yukihsa Shida, Member of the Roppongi Hills Club, Japan, has two different kinds of troubles with the Tsu Family Court and Saitama Family Court in Japan in 2019 as follows.

The Tsu Family Court (Mie Prefecture, Japan)

- # Chief Judge Tamiya says on the homepage, “There are civil mediation (mainly carried out at a summary court) and family mediation (carried out at a family court) where a mediation committee, which consists of two mediators who are socially experienced and have technical knowledge and one judge, resolves disputes based on the agreement of two parties, by listening to their circumstances and requests.”
- # At the mediation conference at the Tsu Family Court on October 15, 2018 (attendees were two persons in charge at the court and myself totaling three persons), one of the two persons in charge (mediator, part-time judicial scriveners) talked loudly for more than one minute one-sidedly, cutting me off, right in front of me who was the party concerned in the mediation.
- # They didn’t say anything about a claim pointed out as a trouble after I sent a letter to Chief Judge Toshiro Tamiya of the Tsu Family Court dated October 21, 2018. They didn’t contact me at all and continue to have the mediation discussion as if nothing happened.

The Saitama Family Court (Saitama Prefecture, Japan)

- # The legal act for adult guardianship for my mother that the Saitama Family Court and the lawyer have taken in tandem according to the law since January 11, 2019 is, as I told in the document I sent to Lawyer A dated March 1, 2019, one that disregards courtesy and business manners from the Shida family’s point of view.
- # They didn’t say anything about a claim pointed out as a trouble after I sent letters to guardian of adult dated March 1, 2019 and to Chief Judge Hiroshi Kohashi of the Saitama Family Court dated May 1, 2019. They didn’t contact me at all and continue to have mediation discussion as if nothing happened.

Last month, June 1, 2019, a 77 year-old former Administrative Vice Minister of the Ministry of Agriculture, Forestry and Fisheries in Japan stabbed his 44 years old son to death with a kitchen knife who was a recluse for many years in his house in Tokyo. A female commentator said on a Japanese TV program, “He knew a consultation counter could help a person who secludes himself/herself in his/her house and does domestic violence. However, he did not consult his family’s trouble because he failed to educate his son.” On the other hand, Dr. Yukihisa Shida will take a vacation in Las Vegas where there are many shows and Hollywood from June 28 to July 3, and stay at the Caesars Palace Hotel Las Vegas from July 28 to 30 and Magic Castle Hotel Hollywood in Los Angeles on July 1, 2019 and wrote letters to Secretary Mariko Watahiki of the Nagoya High Court on July 21 and Secretary Michiharu Hayashi of the Tokyo High Court in Los Angeles on July 1, 2019. It is embarrassing that Secretary Mariko Watahiki and Michiharu Hayashi also have bachelor level education and achievements unlike Dr. Yukihisa Shida and Dr. Tani Cantil-Sakauye who have doctor’s degree. However, the Nagoya High Court is an upper court of the Tsu Family Court and Tokyo High Court is an upper court of the Saitama Family Court in Japan.

In other words, I think that Dr. Tani Cantil-Sakauye, Chief Justice of Supreme Court of California, will understand a legal act about Dr. Yukihisa Shida’s (late) father’s brother by two persons in charge of mediation who do not have a discussion in a calm manner at a legacy division mediation conference for the total amount of more than 350 million yen (3.1 million US dollars to be divided by 10 people of the Shida Family) conducted by Chief Judge Toshiro Tamiya, the Tsu Family Court, Mie Prefecture and clerical work on adult guardianship and legal act about Dr. Yukihisa Shida’s mother who owns an estimated more than 50 million yen (4,500 US\$) in assets carried out by guardian of adult who is given guidance from Chief Judge Hiroshi Kohashi, the Saitama Family Court, Saitama Prefecture, and doesn’t observe business manners or have good manners to Dr. Shida. A M.D., Ph.D of Mie University, who is specialized in internal medicine, sports and medical education, questions culture (*Kyoyou*) and good sense (*Ryoushiki*) of Secretary Mariko Watahiki of the Nagoya High Court and Secretary Michiharu Hayashi of the Tokyo High Court. Even if Chief Judge Toshiro Tamiya of the Tsu Family Court and persons in charge of mediation, as well as Chief Judge Hiroshi Kohashi of the Saitama Family Court and guardian of adult don’t have culture and good sense, Secretary Mariko Watahiki of the Nagoya High Court and Secretary Michiharu Hayashi of the Tokyo High Court are required to have culture and good sense. [We should be careful that those who have bachelor’s degree sometimes allude to a person with a doctor’s degree as a child, greenhorn, nurse, bellow, Mr./Ms.(*San*) ...according to their conscience (*Ryoushin*)(?). Even in European (Spanish, Italian...) football league matchies, we can hear some football fans talk down to players, giving harsh words inside and outside the football ground.] It is not necessarily mean that human beings can do anything as long as it is legal.

Dr. Shida believes that “Paper on June 21, 2019 (The Nagoya High Court, Japan)” and “Paper on July 1, 2019 (The Tokyo High Court, Japan)” on the academic homepage “chairperson.jp” is useful not only for Japanese specialists of the legal circle but also for Chief Justice of Supreme Court of California, Dr. Tani Cantil-Sakauye and American specialists of the legal circle of California will study on two kinds of troubles of Japanese administration of justice in resent years on the academic homepage “chairperson.jp”. From this view point, Dr. Shida’s six-day trip to Las Vegas and Hollywood from Tokyo will consist of both business and pleasure like many other business trips in the past. As Dr. Tani Cantil-Sakauye knows, a Japanese newspaper group (*Keiretsu*), Asahi Shimbun (which has been affiliated with the New York Times for 90 years) Group does not necessarily have its history and tradition to discuss in a calm manner and protect their sources. And when I stayed at the Bellagio Hotel Las Vegas and requested him to play “My Way” at the Lobby Bar and Lounge before, a pianist who put a picture with (former) President Barak Obama on the piano. He might forget to play my request. He possibly worked looking toward the President, not for the hotel guest at the Bellagio Hotel Las Vegas. Doctors are expected to know the purpose of work and discuss with a feeling of tension in a calm manner, then protect personal information.

Lastly, there are academic papers about the backdoor universities on the homepage “chairperson.jp” in addition to papers to the courts. Fujita Health University, Aichi Medical University, Teikyo University and Tokyo Medical University whose backdoor admissions were published worldwide in the 21st century, ... are famous in Japan. It costs more than sixty million yen (5,500 US\$) for backdoor candidates, the same as backdoor medical student, **Takatoku Sano (Mediocrity «Bonsai») of Tokyo Medical University** who used a secretary of Diet Member Kouji Taniguchi who graduated from Waseda University as an entrance examination broker. Most Japanese specialists of the legal circle recognize that **a rich graduate student of Fujita Health University (Mediocrity «Bonsai»)** asked a staff of pinball salon (Japanese style casino) to become a stand-in to take the National Medical Practitioners Qualifying Examination. A Judge called it “*Chaban* (farce)” at one of the wealthiest universities (Fujita Health University, University of the Sacred Heart, Tokyo....) in Japan.
