Dr. Shida asks Prof. Wolpaw and Prof. Wong

I couldn't attend your lectures at the 48th University of Tokyo Medical Education Seminar on November 1, the 49th Seminar on December 12, 2012 and can't attend the 51st Seminar on March 28, 2013 because of my part time job at a hospital for elderly patients located a 20-minute drive away from the Narita International Airport in which I usually see most of outpatients. This is a question raised at the 50th Anniversary Seminar for two professors from the USA, Prof. Daniel Wolpaw and Prof. Jeffrey Wong. What do you think about two representative professors of the University of Tokyo Medical Education Center who did the University of Tokyo's traditional "Academic Harassment" to the doctor and chairperson of sports? Prof. Kazuhiko Yamamoto dropped his head abruptly when he passed me (Dr. Shida) or we saw each other on March 14, 2012 and Prof. Kiyoshi Kitamura did quite the same harassment on May 22, 2012, like Mr. Hideya Sugio, Vice President of the TBS (Tokyo Broadcasting System) News had done to one of other anchors in the TV News program before. Then, they and their cronies spoke ill of me such as "*Baka* (foolish)," "*Ochiru* (inferior)," "*Kiteiran* (reject to join a meeting)," "*Tsukaenai* (no ability)," "*Okashii* (sickness)" ... behind my back.
