Dear Ms. Kigoro,

Happy New Year.

The Roppongi Hills Club (51st floor, Roppongi Hills, which houses two Bar Lounges, five restaurants and three banquet and conference halls), one of the Japanese leading members-only clubs, conducted the questionnaire survey targeted at members conducted again on November 17, 2020. Today let me take this opportunity to give you an update on the situation after I wrote comments as given below on February 1, 2020 1) ~ 5) in blue:

1) About the Bar Lounge Fifty-one: Regarding a Club guest issue, visitors in a group are so loud (it is not unusual that their voice is carried from the Bar Lounge to the restaurant), making the atmosphere of the lounge like that of a company's canteen or a private mediocre university's cafeteria for students and teachers. Its ambience stands in stark contrast to that of the Bar Lounge at the Ark Hills Club (in Ark Hills, Tokyo), which is a membership-based club and an affiliate of the same group as the Roppongi Hills Club, as you are aware, and the Lobby Lounge & Bar at the Ritz-Carlton Hotel Tokyo.

→ The number of guests (members and visitors) who use the Club plummeted on the back of the spread of the novel coronavirus infection in 2020, but Fifty-one's atmosphere has remained unchanged. I heard that the Lounge Fifty-one will be renovated in the first half of 2021, so let me suggest that you should provide a live music performance as the Ark Hills Club and the Ritz-Carlton Hotel Tokyo do in their Bar Lounge and Lobby Lounge & Bar, respectively. At the Steak House in Washington D.C., one of the top 10 steak restaurants in the U.S., they offered a live piano performance when I had dinner many years ago.

2) The way sushi chefs talk at the Sushi Bar: I have told them not to use "Daijobu (OK)," "Daijobu-desuka (are you all right?)," since I joined the club in May, 2018. In 2019, they finally didn't tell me "Daijobu-desuka?," "Daijobu-desuka?," which provided a good atmosphere. I appreciate it.

→ In 2020, I visited the Club 31 times throughout the year, of which five times I had an opportunity to have sushi at the Sushi Bar. Again, sushi chefs and a manager of the restaurant said to me "Daijobu-desuka?," "Daijobu," many times from inside of the counter. In addition, I saw a male floor staff member repeatedly saying "Daijobu-desuka?," "Daijobu-desuka?" to two male guests in suits when they left the counter. They appeared to have a negative impression as long as I saw their faces.

For your reference, I have called the Consultation Desk at Tokio Marine & Nichido Fire Insurance Co., Ltd., which provides free legal and tax consultations for policyholders, more than five times in the past. I remember I got fed up many times with the fact that a lawyer and certified tax accountant in charge, with whom the company



indirectly makes a contract, had so bad business manner that they looked like foolish *Bankara* (rough and uncouth) who graduated from private Waseda University (Tokyo) where 20 – 30% of the students are mediocrities and dominate the whole university. [Reference: “Paper on April

21, 2020 (Aichi Bar Association, Japan) posted on the academic homepage, “chairperson.jp”] It goes without saying that it is hoped that your club will hire great people because many people want to work at the Roppongi Hills Club as staff. I think you should at least hire a person with a good business manner. It’s not uncommon that some bad-mannered, incapable staff, who lengthen the end of their sentences or say “A!” “A!” or “Uh,” “Uh”



over the phone with a guest, are assigned to the Baycourt Club in Tokyo and Yokohama.

In a Japanese movie, “*Okuotoko (Million Dollar Man)*”, a company owner who gives advice to companies for 150,000 yen (1,460 US\$) per hour as a consulting fee appeared.

An employee of Dentsu Inc., Japan’s largest advertising company, with whom I exchanged a business card at the club’s members party, is on the third highest position in Dentsu. As such, about 3,900 members who passed the screening by the Club are busy every day. It is waste of time for me too to request the Club to improve its staff’s business manners year after year.

Regrettably, chefs at the sushi and tempura counter of Japanese restaurant Hinokizaka, Ritz-Carlton Hotel Tokyo have the same business manner who repeatedly say “*Daijobu-desuka?,” “Daijobu”* as chefs at the Roppongi Hills Club. The manager of the Golden Lion Club, the Imperial Hotel Tokyo (a member of the Leading Hotels of the World), Japan’s most renowned hotel which has lost its standing significantly since luxury hotels including Peninsula Hotel Tokyo and new Place Hotel Tokyo (a member of the Leading Hotels of the World) opened nearby this century, says “*Daijobu-desuka?,” “chatte”* on a daily basis. When I was asked how I liked the grand chef’s original course at a special dinner hosted by Executive Grand Chef Yu SUGIMOTO of the Imperial Hotel at a teppanyaki restaurant, “Kamon” on October 13, 2020 and told a female staff member my feedback, she just said one word, “*Naruhodo (aha or I see),”* which made me feel disappointed with the event team led by the young grand

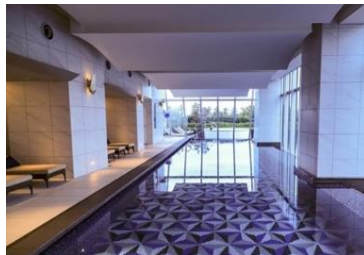


Executive Grand Chef of the Imperial Hotel Tokyo

chef.

On January 3, 2021, I requested the reception staff who work at the Yokohama Baycourt Club and the spa, gym and pool at Kahara Hotel Yokohama concurrently to be more careful by saying, “I stay at the Yokohama Baycourt Club from yesterday and heard some hotel staff say “*Daijobu-desuka?*,” “*Daijobu*” five times. I am a doctor who graduated from a national university. I (a brilliant medical doctor who graduated from national Mie University Graduate School and paid 40 million yen for medical education) don’t want to be regarded in the same way as doctors who graduated from private St. Marianna University School of Medicine or Tokyo Medical University, etc. who paid 60 million yen to enter the private universities through the back door.” On the contrary, sushi chefs at Kyubay, a sushi restaurant I sometimes went to before I entered the Roppongi Hills Club, didn’t have any specific trouble with me about their business manner. The staff of the Main Dining at St. Regis Hotel Washington, D.C., where I stayed at and had lunch on January 29, 2018, did not say to me, “Are you OK (*Daijobu-desuka?*)?” or “All right (*Daijobu*)” in a casual manner. Not surprisingly, the lobby of the hotel, where I took a picture with General Manager Joseph Mattioli, did not have a Bar Lounge Fifty-one-like atmosphere, and I could hear a man who looked like an ambassador stationed in Washington, D.C. saying, “Our country…” in a tranquil tone. - 3) As for the Luncheon Seminar, which is held on a monthly basis, they are frequently held on Thursdays and Fridays, and if possible, I would like you to consider scheduling one on other weekdays, including Monday.
- 4) Regarding the annual Members’ Party, it has been organized in the daytime for quite some time, so let me suggest that you should ask members of the Roppongi Hills Club about their preferences. It seems that the Ark Hills Club almost always holds its members’ party during night-time hours.
- 5) In the past, members of the Ark Hills Club used the Roppongi Hills Club as visitors during the summer. If feasible, I would also like you to consider allowing 1) members of the Roppongi Hills Club to use the Ark Hills Club as visitors for a limited period of time; and 2) a limited number of the Roppongi Hills Club members to participate in a charity event hosted by the Ark Hills Club.

→ Regarding the above 3) ~ 5), due to the COVID-19 pandemic, all the events were practically canceled in 2020. Thus, the aforementioned is a request that I would like you to mull over from this year onward. For your information, I had an opportunity to send a business letter to President Yuji FUKASAWA, East Japan Railway Company in 2020 to mention the above charity event held at the Ark Hills Club. [Reference: “Paper on September 1, 2020 (JR-EAST, Japan) posted on the academic homepage, “chairperson.jp.”]

As an aside, the chief executive officer (CEO) and strategist (an expert who works on investing strategy and his educational background is not disclosed) of an independent research firm, who has a brilliant career, including experiences at Nomura Research Institute, JP Morgan Asset Management (a trader), Credit Suisse Securities (a quants analyst), and UBS Securities (a Japanese stock strategist), and appears in a TV economic news program cooperated with Nikkei Shimbun as a commentator noted that “the Nikkei Stock Average would fall short of 20,000 yen (194 US\$) at the end of 2020” and “The bottom line is investing in high-yield stocks is ‘the most foolish measure,’ given the current stock market conditions” along with the following grounds with full confidence from the summer through the winter 2020 on more than one media under the title “Diagnose Japanese stocks with numbers thoroughly!”. As

it turned out, however, the Nikkei Stock Average hit the first high in 31 years at 27,444 yen (266 US\$) for a year-end closing price on December 30, 2020. Further, Mr. Warren BUFFET, who is referred to as “the god of stocks,” bought Japanese stocks worth 370 billion yen (3.59 billion US\$, 3 companies’ stocks are high-yield of Japan’s big five general trading houses) on his 90th birthday on August 30, 2020, and I, a 58-year-old novice at stocks, switched stocks that were inherited from my uncle in 2020 to buy stocks amounting to 60 million yen (5.8 hundred thousand US\$). Fortunately, both of our stocks remain stable, yielding a good return (a dividend yield of more than 3.0% in Japan).

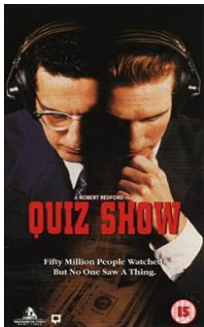
1. Given the corporate sector’s poor performance and the slow economy, the current stock prices are too high
2. Monetary easing policy will not last forever
3. Japanese stocks are not undervalued at all compared with the U.S. counterparts

The reason “investing in high-yield stocks is ‘the most foolish measure’ in the latter half of 2020”

- ① Stock prices fall as much as dividends fall (including shareholder benefits)
 - There is no theoretical rationale for high-yield stocks being attractive
- ② Growth companies attach greater importance to investing in business than to dividend payments
 - Dividends are refunds to investors, i.e. self-denial of a company’s growth
- ③ Capital gain is greater than income gain
 - There are few issues whose range in price per annum falls short of a dividend yield
- ④ High dividend yield = no more than high risk issues that are cheap after being sold
 - A value trap; the less attractive, the higher dividend yield

The Roppongi Hills Club receives very important persons, such as state ministers and ambassadors from various countries, as is the case with St. Regis Hotel, Washington D.C. Please allow me to take this opportunity to suggest that General Manager Kigoro should make efforts to better manage Club staff’s business manner and staff who are not proficient in Japanese so that you may be able to run the Club in a stable and strategic manner without making your distinguished guests feel uneasy or uncomfortable.

For your reference, only doctors can comprehensively diagnose in the medical world. This CEO & Strategist talks the same way as guests at the Bar Lounge Fifty-one and may identify himself with private university doctors by saying “Diagnose thoroughly”, like Makoto SATAKA, a political commentator and graduate of private Keio University (Tokyo) where mediocrities are the large majority, who wrote a book titled “Makoto SATAKA’s Seikei Geka (Makoto SATAKA is a surgeon in the Japanese political world)”. However, given this level of educational



background that is not disclosed, he cannot serve only as doctor who bears a heavy responsibility for diagnosis, but also as pharmacist, nurse, medical engineer, careworker, or clerk in harsh medical settings where we, doctors who graduated from national universities work. Brilliant national universities and graduates of national universities are totally different. As you know, in a Hollywood fact-inspired movie, “Quiz Show,” when a civil servant, a graduate of Harvard Law School, who was strict on the job and became a speechwriter for President John F. Kennedy

later, made a business call to various quarters for the first time, he introduced himself as a brilliant person with successful educational background after one minute.

When President Toshiyasu ITO, The Hyakugo Bank in Mie Prefecture in Japan, my hometown, visits the Roppongi Hills Club, I expect that he will receive not average but professional service from the staff with perfect business manner so that the Club will be admired as a leading membership club with one of the world’s best panoramic views. 2) 2016 年 5 月私入会時からご注意申し上げてます鮭 Bar におきます「大丈夫」「大丈夫ですか」のお言葉使いにつきまして：昨年 2019 年は、板前さんが私に「大丈夫ですか」「大丈夫ですか」とおっしゃらなくなりまして、雰囲気がよくなりました。有難うございます。

→ 2020 年は年間を通じて私六本木 Hills Club に 31 回訪れてまして、そのうち 5 回鮭 Bar でいただく機会がありましたが、再び「大丈夫ですか」「大丈夫」と何度も寿司 Counter 内から私に、鮭 Bar 店長を含む板前さんから話されました。また鮭 Bar Floor の男性 Staff も、Suit 姿の男性 Guest お二人が Counter 席を立たれた際、「大丈夫ですか」「大丈夫ですか」と何度も Guest に繰り返えしてみえ、その男性客お二人もお顔を拝見しました限り良い印象はお持ちでないご様子でした。

ご参考までに、私 東京海上日動火災保険（株）の保険契約者無料法律及び税金 電話相談窓口に過去 5 回以上ご相談の電話をさせていただいてますが、東京海上日動が間接的に契約してみえる担当



弁護士さん、担当税理士さんが、それぞれ（凡才学部生が 2~3 割を占め、凡才が支配的な空気でみえる）私立早稲田大学ご出身の「あほくさい蛮カラ」と思えるほど悪い Business Manner でみえましたため、私閉口してしまいました記憶が何度もあります。[参考文献：学術 Homepage「Paper on April 21, 2020 (Aichi Bar Association, Japan)」]

六本木 Hills Club でしたら Staff の採用希望者はいくらでもいらっしゃいますので、優秀な人材が望まれることは言うまでもありませんが、最低でも Business Manner の身に付いてみえる人にご勤務いただいた方がよろしいかと思えます。東京及び横浜 Baycourt 倶楽部でも語尾を延ばされたり、「あっ」「あっ」調、「えーと」調など、Guest からの電話応



対に対して Manner が十分お出来にならない、能力のない Staff の配置が珍しくありません。日本映画「億男」には、企業の考え方指南等 Consult 料が 1 時間当たり 15 万円の会社経営者が出てきますが、六本木 Hills Club の Member's Party で名刺交換をさせていただいた日本最大手広告代理店 株式会社電通の社員の方も、電通社内で No. 3（3 段目）程の Position でみえました。六本木 Hills Club の会員資格審査を通られた現 3,900 名の会員皆様の多くは多忙な日常を送っていらっしゃいまして、

私も毎年毎年六本木 Hills Club へ Staff 皆さんの Business Manner について改善依頼を出させていただくのは時間の無駄です。

を前面に出された上、「2020 年年末の日経平均株価は 2 万円割れへ下落」、「結論を言えば、高配当利回り株への投資は、今の株式市場の現状を踏まえると『最悪の愚策』」などの予想を下記根拠と共に 2020 年夏から冬にかけて複数の Media で自信たっぷりに述べられてましたが、結果、日経平均株価は惜しまらくも 2020 年 12 月 30 日に 27,444 円と年末終値として 31 年ぶりの数字として高値更新されました。さらに「投資の神様」と言われる Warren BUFFETT さんがご自身 90 歳の誕生日 2020 年 8

月 30 日に 3,700 億円分 (日本の 5 大商社のうち 3 社が高配当利回り) 程購入された株と、「投資の素人」と言われる 58 歳の私が昨年 2020 年伯父さんよりの遺産相続株を手元に銘柄を入れ替え 6,000 万円程購入しました株 (日本の Megabank 3 Group と商社 3 社) は、共に高配当株 (配当利回り 3.0% 以上) ですが、お陰様で取り敢えず大丈夫。堅調に推移しています。

弱気ポイント

年末に日経平均は **2万円割れ**へ下落

- 1** 業績・経済が悪いのに現状の株価は上げすぎ
- 2** 金融緩和がいつまでも続くわけではない
- 3** 日本株は米国株に比べ決して割安ではない

2020 年年末に、日経平均が 2 万円を割れる理由

- ①：配当は、落ち分と同じだけ株価が下がる (優待も)**
→ 高配当利回りが魅力的という理論的な根拠はない
- ②：成長企業は、配当支払いよりも事業投資を重視する**
→ 配当は投資家への払い戻し金、企業の成長の自己否定
- ③：インカムゲインよりもキャピタルゲインの方が大きい**
→ 年間の値幅が配当利回り未満の銘柄はほとんどない
- ④：高配当利回り = 売られて安いだけの高リスク株**
→ バリュートラップであり、魅力が低いほど高配当利回り
